(FOR APPLICANTS RESIDING IN DELHI, PUNJAB & NCR)**

**NISHKAM MCM SCHOLARSHIPS 2026**

**Eligibility Criteria**

These scholarships are available for students pursuing professional and Non Professional diploma / degree / postgraduate courses from recognized institutions / universities in India.

The applicant should be a resident of **Punjab, Delhi and NCR**.

The applicant must have obtained at least **60% marks** in the previous two examinations (exception in some streams like C.A. / C.S. etc.).

The gross family income of the applicant must not exceed **Rs. 3,00,000/- per annum**.

Age should be less than 30 years as on 31st March 2026.

Applicants must maintain an active email account for correspondence with Nishkam and provide a mobile number as well as an alternative telephone number for easy communication.

The criteria of selection will be a Written Test by Eligible applicants followed by an Interview. The Admit-Card along-with Roll Number for Written Exam will be sent by Email. The written exam will essentially test the applicant's Language Skills, General Knowledge, Moral education and Reasoning ability.

**Last date to submit Application Form is 15<sup>th</sup> February, 2026.**
